All,

I conducted a site investigation yesterday, March 27, 2013, at Eagle View Farm with the operator, Mr. David Jones. Mr. Jones most recent flock of birds acquired necrotic dermatitis leading to an increasing percentage of mortalities. Normal mortality percentages per house per flock are usually close to 5% but with this flock the house with the highest percentage was slightly over 13%. Equity Group is the poultry supplier for Eagle View Farm. Equity Group generally "grows" non-medicated birds, so the decision was made to remove the remaining healthy birds instead of medicating them at the farm. The birds were removed on March 20 and 21, at an age of seven weeks plus one to three days, which is a normal age/grow-out timeframe. The mortalities were properly handled according to the approved Nutrient Management Plan (NMP) by composting on site in the existing compost bin. There are some very small areas of spillage due to a complete litter cleanout, but all litter was handled in accordance with the approved NMP. Mr. Jones has been de-caking for the past few years and was preparing to do a complete cleanout at the end of his next flock, but with the recent necrotic dermatitis, the cleanout has to occur prior to getting a new flock of birds. So far there have been approximately 250 tons of litter removed from one house with a couple of loads remaining. Then the five other houses will be cleaned out in the same manner. The conveyor belt used for loading litter broke and Mr. Jones is awaiting a replacement before removing any more litter. Various trucks haul the litter to other farms to be spread. Mr. Jones' mortality and litter records were in order. As with any cleanout, there is some spillage around the doors and loading areas. Mr. Jones has been scooping this spilled litter back into the house. Once the cleanout is complete, he will spray liquid alum inside each house to help with mold, which is routine before putting in a layer of sawdust. No other issues were observed during the site visit.

Additionally, Mr. Jones received a visit last week from Harley Sutton and Wes Montooth with the State Veterinarian's office. According to Mr. Jones, they gave him no instructions and had no issues. I spoke with Mark Hudson, Department of Agriculture. He agreed with Mr. Jones process of handling this issue and had no additional suggestions.
