Oscar,

In context of our April 25th, 2024, telephone conversation I am formalizing what we discussed concerning the above referenced NPDES Permit.

Mid South Engineering Consultants LLC (MSEC) has submitted a sewer design to TDEC's review to replace the existing Extended Aeration Package Plant with a Low-Pressure Pipe Subsurface disposal of treated wastewater. The proposed new system will not have a discharge. The consensus of the Preliminary Project Discussion (PPD) Teams meeting was to keep the NPDES Permit active and modify it as opposed to changing the permit to a State Operating Permit (SOP). The reasoning being that should an open discharge be required in the future, the NPDES Permit would, more than likely, no longer be an option for the facility.

Based on my understanding of our conversation, the NPDES Permit modification would begin once construction of the new treatment system had begun and a schedule of completion was determined. The modified permit would also require some minimal sampling and the system will require a certified operator to oversee the mechanical functions of the treatment system and for the sample collection and Monthly Operating Reports (MOR's) submissions.

Please advise if I have stated anything incorrectly or need to provide additional information.
