**Notice of Coverage Fact Sheet**

The Division of Water Resources received from your company a Notice of Intent (NOI) to be covered under the General NPDES Permit for Discharges of Storm Water Runoff and Process Wastewater Associated with Ready Mixed Concrete Facilities (RMCP). The new RMCP general permit was issued on October 31, 2017, with an effective date of November 1, 2017, and an expiration date of October 31, 2022. **We have recorded your facility's information and are hereby notifying you that your facility is covered under this RMCP general permit.**

Enclosed with this fact sheet you will find a Notice of Coverage with the permit tracking number, facility's name, address, receiving stream information and other site-specific information that applies to your facility. Please remember that all off-site washout locations require written approval of the property owner and notification to the local Field Office. 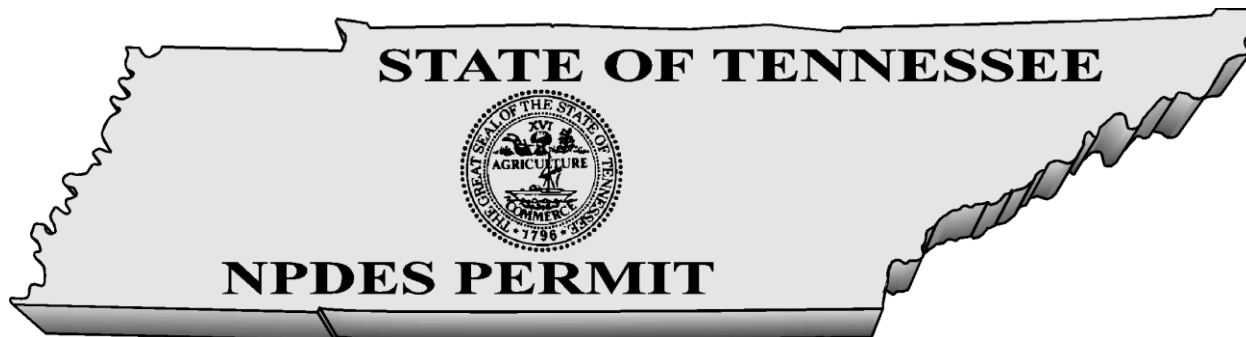

Under authority of the Tennessee Water Quality Control Act of 1977 (T.C.A. 69-3-101 et seq.) and the delegation of authority from the United States Environmental Protection Agency under the Federal Water Pollution Control Act, as amended by the Clean Water Act of 1977 (33 U.S.C. 1251, et seq.):

Discharger: **CXT Incorporated dba VanHooseco**

Is authorized to discharge: **Process waste water and storm water discharges into adjoining quarry pond**

From a facility located: **2131 Murfreesboro Road in Lebanon, Wilson County**

To receiving waters named: **Blue Water Quarry Pond**

in accordance with effluent limitations, monitoring requirements and other conditions set forth herein.
