## Dear Mr. Bright:

We have reviewed and approved the Megasite Authority of West Tennessee's application for a revision to previously issued Aquatic Resource Alteration Permit NRS18.288, for impacts related to the Memphis Regional Megasite's force main outfall to the Mississippi River.

Authorized impacts include a revised permitted force main outfall design and location in the Mississippi River, such that the force main pipe will extend beneath the banks via HDD and terminate approximately 160 beyond the previously permitted outfall location. The pipe will penetrate through an existing layer of articulated concrete matting at its outlet, with rip rap added to the outlet to minimize future erosion.

All other authorized impacts to jurisdictional aquatic resources remain as previously permitted and conditioned under NRS18.288.

The planned activity was reviewed and the Division has reasonable assurance that the activity as proposed in accordance with all permit conditions herein will not violate applicable water quality standards and has issued the attached revised permit (enclosed). This permit may also serve as a §401 water quality certification (pursuant to 40 C.F.R. §121.2).

The state of Tennessee may modify, suspend or revoke this authorization or seek modification or revocation should the state determine that the activity results in more than an insignificant violation of applicable water quality standards or violation of the TWQCA. Failure to comply with permit terms may result in penalty in accordance with T.C.A. §69-3-115.
