The Petrie farm is in Weakley or Henry County. Due to the animal numbers, FSA had to complete a Class II environmental assessment. The environmental assessment resulted in a Finding of No Significant Impact (FONSI). FSA required the owner of the farm to publish a three day notice for comment in their local paper and provide copies to all consulting agencies and the EPA as a courtesy to acknowledge the status of the project and the Agency finding. We've done this before and I thought TDEC had received a copy. It's been awhile and the last notice may have gone to Jim McAdoo. If you have questions, give me a call. Thanks.
