Thank you for your report. We appreciate TDEC's expertise and guidance. 100% compliance with our NPDES permit is our goal and we committed to continuing to improve.

As a result of conversations with TDEC staff during the inspection, the following improvements have been made:

5	ID who collects samples on Bench Sheet.	Bench Sheet has been revised.
6	Email Oakley (cc: Jenny) several MicroBac reports	Done: 6-9-21
7	Reduce size of storage container for disposal of Headworks screenings.	Done: 6-7-21
8	"The permittee shall sign up for electronic reporting of Discharge Monitoring Reports using NetDMR within 90 days of the permit effective	In progress: currently awaiting TDEC authentication of signatory's identity.

## **Required Actions**

- 1. "Review the sampling and chain of custody documents for all tests being performed and outsourced by the sewer treatment facility." Pursuant to the required language of the NPDES permit pg. 5 section 1.2.4:
  - Ranch staff "shall record the following information: a) The date, exact place, and time of sampling or measurements; b) The individual(s) who performed the sampling or measurements;"
  - b. MicroBac staff shall record the following information: "c) The date analyses were performed; d) The individual(s) who performed the analyses; e) The laboratory where the analyses were performed; f) The analytical techniques or methods used; and g) The results of such analyses.
- 2. "Please contact an environmental engineer to assess the facility. Determine the needs of the patrons as that relates to the loading of the facility. Consider the needs of the recently issued NPDES permit. Consider and discuss the construction of a new treatment facility."
  - a. We agree with your observation that future plans for facility updates need to be considered and proceed with this course of action.
