The Division of Water Resources (DWR) appreciates the dedicated effort of Clearfork Utility District to meet the requirements of the Tennessee Safe Drinking Water Act (SDWA).

The Consumer Confidence Report rule requires community water systems deliver a copy of the CCR to DWR by July 1 every year and deliver the CCR Certification and its associated documentation to DWR by October 1 every year. Additionally, all content requirements for the CCR must be met. Clearfork Utility District fulfilled all CCR rule requirements for the 2022 CCR; therefore, DWR rescinds the violation identified in the letter dated October 19, 2023.
