Dear Mr. Sengchanh:

The Concentrated Animal Feeding Operation (CAFO) permit renewal application for your farm was received on January 28, 2015 (with revisions received on February 4, 2015). This letter is to inform you that your application has been reviewed and approved by TDA staff. Your application materials have now been forwarded to the Tennessee Department of Environment and Conservation (TDEC). Currently, TDEC, the agency responsible for issuing and renewing permits, is updating the General State Operating Permits. Upon completion of the permit revisions, TDEC will issue new General State Operating Permits, under which your operation will be permitted. Until that time, a permit renewal cannot be issued. TDA has informed TDEC of your submission, which confirms your compliance with the reapplication deadline as set forth in your permit. You do not need to take any additional action at this time regarding your permit renewal. Additional information may be requested at a later date. Thank you so much for your prompt attention to renewing your permit, and either TDA or TDEC will contact you when the new General State Operating Permits have been issued.

**PLEASE NOTE**: This approval notice <u>does not</u> constitute a CAFO permit – it is merely meant to notify you that the renewal application you submitted has been approved by TDA. TDA approval of your application is a necessary step towards renewing a CAFO permit, but ultimately TDEC is the agency responsible for issuing your CAFO permit.
