Dear Mr. Adams:

On February 25<sup>th</sup>, 2015, I conducted a Compliance Evaluation Inspection of the filter backwash facilities at the North Utility District of Benton and Decatur Counties' Water Treatment Plant.

The only significant finding of concern was the lack of preparedness of the facility to sample the discharge of the sedimentation basins. Please be aware that according to the conditions of your permit, the discharge from the basins must be sampled and tested at least once per month, if there is a discharge at any time during the month. A list of the effluent limits that apply to your facility are given in your permit's "Notice of Coverage Fact Sheet", a copy is attached. Please note that all tests shall be performed using methods prescribed in 40 CFR Part 136.
