Dear Ms. Brantley,

On May 10, 2018, the Division of Water Resources ("Division") issued State Operation Permit SOP 18010 ("Permit"), authorizing Southeastern Provision, LLC ("Respondent") to pump and haul its industrial process wastewater until April 30, 2020. The Permit was later modified, extending the expiration date to June 30, 2020. The Permit was granted in accordance with Director's Order WPC18-0030 ("Order"), allowing the Respondent to implement a new wastewater disposal system while maintaining facility operations.

The Respondent has submitted plans to the Division to implement a new decentralized wastewater disposal system. The Division agrees to modify the Permit, authorizing pump and haul disposal until June 30, 2021, provided the Respondent is working towards implementing the Division-approved wastewater system. Following this Permit extension, the Permit shall expire after the one-year extension and the Respondent shall no longer have authorization to pump and haul its wastewater. At which point the Respondent shall be using the fully operational decentralized wastewater disposal system in accordance with its corresponding permit and all regulations set forth therein. Should the Respondent fail to fulfill its obligation to complete the Division-accepted wastewater disposal system in time, the Division may take additional enforcement action.
