Dear Mr. O'Toole,

The Tennessee Division of Water Resources (The Division) has conducted a routine Compliance Status Review of the Discharge Monitoring Reports (DMRs) for ATC Group Services, LLC NPDES permit TNG830265. It has been noted that the facility failed to conduct effluent analyses at Outfall 001 for the quarterly monitoring period of July 01, 2023 - September 30, 2023, as detailed in the attached Violations Report.

The Division of Water Resources requests a written explanation for the violations summarized above within 30 days of receipt of this Notice. The explanation should include the precise cause of the violations and the corrective action taken to avoid future violations. Documentation should be sent to the address listed above or you may email a copy to <a href="mailto:DWRWater.Compliance@tn.gov">DWRWater.Compliance@tn.gov</a>. If you believe the violations listed in the attached table have been identified incorrectly, please provide documentation to our office within fifteen (15) days of receiving this correspondence. Please be aware that failure to comply with your NPDES permit may subject you to enforcement action. Pursuant to T.C.A. §69-3-115, civil penalties may be assessed for each day a violation occurs or continues.
