Dear Mr. Daniel:

The Tennessee Department of Environment and Conservation, Division of Water Resources, acknowledges receipt of final construction documents on August 14, 2020.

This project consists of repairing and repainting four water storage tanks along with cleaning and repair of the Powell Street WTP Clearwell. Two tanks (100,000 gallon Church Street tank & 500,000 gallon Anderson Avenue tank) will have the interior and exterior recoated. Two tanks (500,000 gallon American Air Filter tank & 500,000 gallon King Street tank) will have the exterior only recoated. As indicated by our stamp, this project has been approved for construction.

This letter, with the enclosed engineering documents bearing our official stamp, constitutes approval by the Commissioner of the Tennessee Department of Environment and Conservation for construction of the referenced facility. Approval is granted in accordance with the Tennessee Safe Drinking Water Act of 1983 and Regulations of the Tennessee Board of Water Quality, Oil and Gas. One complete set of plans and specifications, bearing the official stamp, must be kept at the construction site. Projects utilizing previously approved standard specifications are not required to maintain a stamped copy of the specifications at the construction site. All construction must conform with these approved documents. It is the responsibility of the water utility and/or their engineer to ensure that construction conforms to the plans and specifications. We have retained one copy of this submittal for our records.

Approval expires one year from the stamped approval date unless construction is either underway or complete. Any request for its extension must be made prior to this expiration date. Deviations from the approved plan documents which may affect the quality or quantity of potable water must be submitted and approved in writing before such changes are made. The Division's appropriate Field Office may desire to schedule an inspection of the construction work to verify compliance with the approved plans and specifications. Therefore the engineer or the water utility shall <u>notify the Jackson Field Office of the start of construction</u>. This notification may be made by completing and mailing the attached "Construction Start Notification" form to the field office.
