Dear Mr. Burden,

The Tennessee Division of Water Resources (The Division) has conducted a routine Compliance Status Review of the Discharge Monitoring Reports (DMRs) for B & B Concrete Products, Inc. NPDES permit TNG110241. It has been noted that the facility failed to electronically submit the DMRs for Outfall 001 for the quarterly monitoring period of July 1, 2023, to September 30, 2023, as detailed in the attached Violations Report.

Please resolve the above violations within thirty (30) days of receipt of this letter by submitting the outstanding DMRs in NetDMR. Additionally, the Division requests a written explanation for the violations summarized above within 30 days of receipt of this notice. The explanation should include the precise cause of the violations and the corrective action taken to avoid future violations. Documentation should be sent to the address listed above or you may email a copy to <u>DWRWater.Compliance@tn.gov</u>. If you believe the violations listed in the attached table have been identified incorrectly, please provide documentation to our office within fifteen (15) days of receiving this correspondence. Please be aware that failure to comply with your NPDES permit may subject you to enforcement action. Pursuant to T.C.A. §69-3-115, civil penalties may be assessed for each day a violation occurs or continues.
