

GENERAL EROSION AND SEDIMENT CONTROL NOTES

1. THE AREA IDENTIFIED AS LIMIT OF DISTURBANCE IS FOR EXCESS TOPSOIL ONLY. NO DUMPING OF CONSTUCTION DEBRIS SHALL BE ALLOWED. OTHER EXCESS EARTHEN MATERIAL SHALL BE DISPOSED OF BY THE CONTRACTOR AS HIS EXPENSE. THIS MATERIAL MUST BE DISPOSED OF AT A TDEC PERMITTED SITE. IF THE CONTRACTOR'S WASTE SITE IS NOT PERMITTED, HE SHALL NOTIFY THE ENGINEER AND THAT SITE SHALL BE ADDED TO THIS STORM-WATER POLLUTION PREVENTION PLAN.

2. CONTRACTOR SHALL KEEP A 30-BUFFER BETWEEN THE SILT FENCE AND TREE LINE. 3. THE TOTAL DISTURBED AREA IS ESTIMATED TO BE APPROXIMATELY 0.25 AC. SHOULD THE CONTRACTOR EXCEED THE 0.25 AC. HE SHOULD CONTACT THE ENGINEER AND HAVE THE SWPPP AND NOC AMENDED TO INCLUDE THE ADDITIONAL AREA.

4. SEE SHEET C4-1 FOR ADDITIONAL SEDIMENT AND EROSION CONTROL NOTES. 5. IF THE STOCKPILE IS LEFT UNDISTURBED FOR MORE THAN 14 DAYS, AREA SHALL RECEIVE TEMPORARY SEEDING.
