## Tennessee Multi-Sector Permit (TMSP) Notice of Coverage Fact Sheet

We received from your company a Notice of Intent (NOI) to be covered under the Tennessee Storm Water Multi-Sector Permit (TMSP). The new TMSP became effective on July 2020, and expires on June 30, 2022. We are hereby notifying you that your facility is covered under this general permit. The facility's SWPPP shall be modified to address additional requirements in the new permit no later than $\mathbf{6 0}$ days following the effective date of this permit.
Enclosed with this fact sheet you will find a Notice of Coverage with the permit tracking number, facility's name, address, receiving stream information and the industry-specific sector(s) that apply to your facility.
