Tennessee Multi-Sector Permit (TMSP)
Notice of Coverage Fact Sheet

We received from your company a Notice of Intent (NOI) to be covered under the Tennessee Storm Water Multi-Sector Permit (TMSP). The new TMSP became effective on April 15, 2015, and expires on April 14, 2020. **We are hereby notifying you that your facility is covered under this general permit. The facility's SWPPP shall be modified to address additional requirements in the new permit no later than 60 days following the effective date of this permit.**

Enclosed with this fact sheet you will find a Notice of Coverage with the permit tracking number, facility's name, address, receiving stream information and the industry-specific sector(s) that apply to your facility. 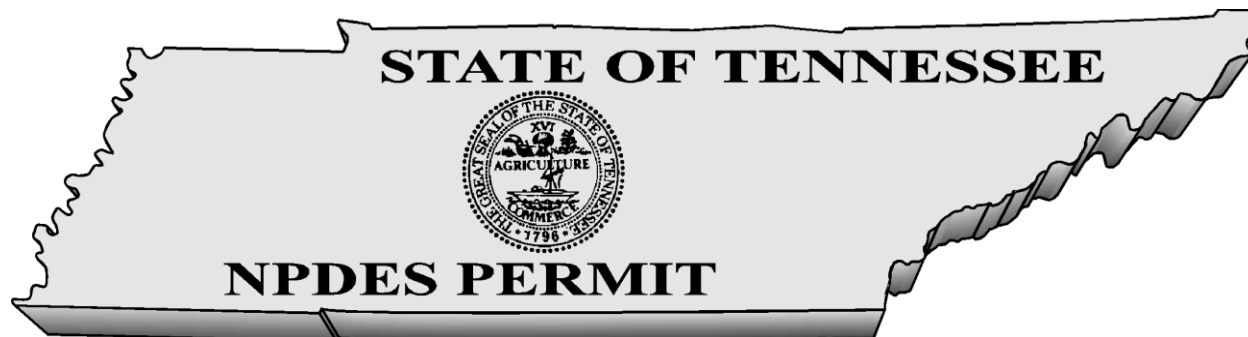

Under authority of the Tennessee Water Quality Control Act of 1977 (T.C.A. 69-3-101 et seq.) and the delegation of authority from the United States Environmental Protection Agency under the Federal Water Pollution Control Act, as amended by the Clean Water Act of 1977 (33 U.S.C. 1251, et seq.):

Discharger: **Fedex Freight East, Inc. - Lewisburg CC**

is authorized to discharge: storm water associated with industrial activity

from a facility located at: **995 Spring Place Road in Lewisburg, Marshall County**

to receiving waters named: **Collins Creek**

in accordance with effluent limitations, monitoring requirements and other conditions set forth herein.
