Mr. Hudson:

The Tennessee Division of Water Resources (The Division) has reviewed the Discharge Monitoring Reports (DMRs) for Cumberland Supply Co., Inc., and noted the facility failed to submit DMRs for the quarterly monitoring periods of October 1- December 31, 2019, January 1- March 31, 2020, April 1- June 30, 2020, and July 1- September 30, 2020. These violations were identified through a routine compliance status review.

The Division requires the data, or an appropriate no discharge code be entered into the NetDMR system within 30 days of receipt of this notification and requires a written response to this notice of violation. The response should provide an explanation for the violations summarized here within 30 days. The explanation must include the precise cause of the violations and the corrective action taken to avoid future violations. This should include any relevant information previously conveyed to the Division, along with any updates or changes. Please be aware that failure to comply with your NPDES permit may subject you to enforcement action. Pursuant to T.C.A. §69-3-115, civil penalties may be assessed for each day a violation occurs or continues.
