According to information submitted to the DRUC by the Hillsville Utility District, the existing inter-basin transfer of water by the DRUC from the Tennessee Western Valley River Basin to the Manchester Water & Sewer Department then to the HUD that then crosses into the Upper Cumberland River Basin has not exceeded grandfathered levels.

Information supplied to DRUC by the Hillsville Utility District (see attached) also indicates that the grandfathered amount is not expected to be exceeded in the near future.
