Notice of Coverage Fact Sheet**

The Division of Water Resources received from your company a Notice of Intent (NOI) to be covered under the General NPDES Permit for Discharges of Storm Water Runoff and Process Wastewater Associated with Ready Mixed Concrete Facilities (RMCP). The new RMCP general permit was issued on October 31, 2017, with an effective date of November 1, 2017, and an expiration date of October 31, 2022. **We have recorded your facility's information and are hereby notifying you that your facility is covered under this RMCP general permit.**

Enclosed with this fact sheet you will find a Notice of Coverage with the permit tracking number, facility's name, address, receiving stream information and other site-specific information that applies to your facility. Please remember that all off-site washout locations require written approval of the property owner and notification to the local Field Office. 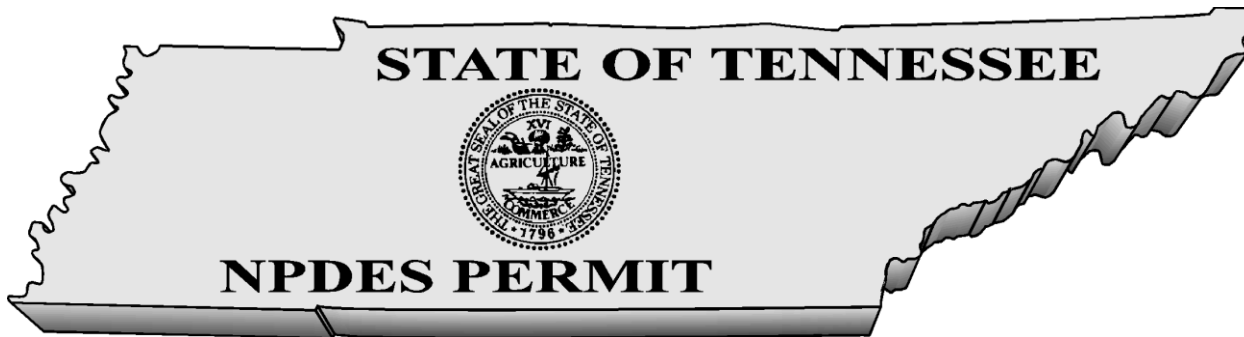

Under authority of the Tennessee Water Quality Control Act of 1977 (T.C.A. 69-3-101 *et seq.*) and the delegation of authority from the United States Environmental Protection Agency under the Federal Water Pollution Control Act, as amended by the Clean Water Act of 1977 (33 U.S.C. 1251, *et seq.*):

Discharger: **Foley Products Company**

Is authorized to discharge: **process wastewater from Outfall 001**

From a facility located: **3950 Cromwell Road in Chattanooga, Hamilton County**

To receiving waters named: **Friar Branch - Exceptional Tennessee Waters due to the presence of species vulnerable to the risk of extinction - the Chickamauga Crayfish, listed by Tennessee as a threatened species**

in accordance with effluent limitations, monitoring requirements and other conditions set forth herein.

Coverage under this general permit shall become effective on **February 15, 2018** and shall expire on **October 31, 2022**.
