Ryan,

As the permit is written, yes the stormwater monitoring would be required within 90 days of the permit issuance or after the first qualifying storm event if there are no events in that 90 day period. However, to be consistent the DMR schedule from the previous permit (biomonitoring submitted in 2022) this can be edited in the final permit to simply be once per permit cycle if you submit a formal comment asking this be changed. A question on the wording within this permit. Biomonitoring requirements for stormwater (Section 3.3) states "The toxicity tests specified herein shall be conducted once per permit cycle and begin no later than ninety (90) days from the effective date of this permit, or as soon thereafter as practicable during a qualifying storm event.". Does this mean that all tox tests for stormwater must be collected within the first 90 days of the permit issuance? It is unclear that the requirements would be once per permit cycle (5 years), but with the caveat of additionally within the first 90 days. Can you provide some clarity?
