The Tennessee Department of Agriculture (TDA) received your application to modify your Concentrated Animal Feeding Operation (CAFO) permit on November 25, 2015 (with additional materials/revisions received on November 30 and December 4, 2015). The primary modifications included an increase in the number of barns from 4 to 6, and the increase in the number of broilers from 144,000 to 318,000 per grow-out. This letter is to inform you that your modification application has been reviewed and approved by TDA staff. Your application materials have now been forwarded to the Tennessee Department of Environment and Conservation (TDEC) for permit issuance.

**PLEASE NOTE:** This approval notice does not constitute a CAFO permit – it is merely meant to notify you that the application you submitted has been approved by TDA. TDA approval of your application is a necessary step towards receiving a CAFO permit, but ultimately TDEC is the agency responsible for issuing your CAFO permit, and they may ask for additional information or materials.
