Alicia and Joanna:

Due to the need for this project in a short period of time, normal timeframes for project development are being compressed. As a result, some steps, which normally wait for the previous step to be completed before starting, are being conducted concurrently. In the case of this project, some design changes are occurring to accommodate issues after the permit application was submitted.

Since the submittal of the permit application on August 11, 2023, some minor changes have occurred that have resulted to changes in impacts to jurisdictional aquatic features. The new

impacts were caused by a new control access fence be placed along the edge of the property boundaries. The impacts are temporary. The control access fence construction will temporarily impact WTL-3A and WTL-5A. The fence will be near WWC/EPH-2A and STR-2A but will impact either feature.

The new impacts increased the temporary impacts for:

- WTL-3A – from 0.039 to 0.059
- WTL-5A – from 0.040 to 0.046

By copy of this letter, we are providing the Tennessee Department of Environment and Conservation and United States Army Corps of Engineers updated sheets showing the change listed above for your files. Plan sheets showing that WWC/EPH-2A and STR-2A are not being impacted by control access fence installation are included also.
