The Department of Environment and Conservation, Division of Water Resources, has received your request for an extension of time to complete the project, previously approved under project number DW20220991 on September 19, 2022. On the basis that no revisions were made to the original submittal, this letter shall demonstrate an extension of one year. Approval now expires one year from February 6, 2024.

The Division's appropriate Field Office may desire to schedule an inspection of the construction work to verify compliance with the approved plans and specifications.
