Dear Mr. Holcomb:

No industry has moved into the area or changed processes since the last exemption was granted

I have enclosed the Pretreatment Exemption Renewal Application.

1. No industry discharges wastewater to the sanitary sewer subject to the Categorical Pretreatment Standard issued by the Environmental Protection Agency.
2. No industry discharges 25,000 gpd or more of process wastewater to the sanitary sewer.
3. No industry contributes process wastewater to the sanitary sewer that makes up 5 percent or more of the average dry weather hydraulic or organic capacity of the sewage treatment plant.
4. No industry discharges wastewater to the sanitary sewer, which has reasonable potential for adversely affecting sewage treatment plant operations.

If this status changes, we will submit a revised IU survey as required.
