Dear Ms. Kauffman:

The Division of Water Resources (the division) acknowledges the receipt of a permit application in our office on March 10, 2016. Our review of the individual construction permit application showed that you have submitted all the information required to initiate processing of the application. You are advised that this notice of complete application does not imply that the application will be approved or that a permit will be issued. Also, in accordance with rules of the Tennessee Department of Environment and Conservation, Division of Water Pollution Control, Chapter 0400-40-5-.05 (2):

“This provision does not preclude the commissioner from later requesting additional material that subsequent to the notice of completeness is determined to be necessary for permit processing.”

Since this is an application for a new, please find attached a template of a public notice you must complete and post for a period of 30 days. This is required in accordance with Chapter 0400-40-5-.06 (1), which states:

“For an individual application for a new or expanded discharge, the applicant shall notify the public of the application by posting a sign near the point of entrance to such facility and within view of a public road. The sign shall contain provisions as specified by the commissioner. The sign shall be of such size that is legible from the public road. Also the sign shall be maintained for at least thirty days following submittal of the application to the division.”

Although we deem the application complete, we do have several comments and observations that should be considered:

- Engineering designs provided were low-resolution and blurry.
- SWPPP references a potential off-site borrow or fill area used solely for the applicant's construction project. That acreage is included in the NOI (Total off site area disturbed 2.27 acres. Site acres to be disturbed 85.23).
- The site areas that drain to supporting waters are designed for the 2-year, 24-hour return interval storm.
- The portion of the site draining to Miller's Creek should be designed for the 5-year, 24-hour storm event. Miller's Creek is listed as impaired for sedimentation/siltation. This may impact BMP designs in the site area draining to Miller's Creek.
- Coverage under Aquatic Resource Alteration Permit NRS16.025 has not been issued.
- Buffer zones appear to exist where required but are not clearly labeled.
- Potential sinkholes north/north east of site may require Class-V Injection Well permit.
