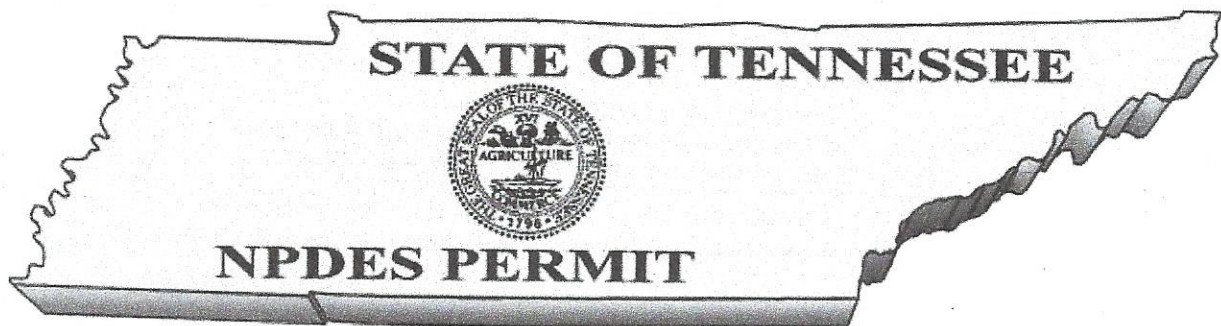
Subject: Notice of Termination Letter: **TMSP #TNR059028**

This letter is to inform the Tennessee Division of Water Resources that Summers Taylor Inc. would like to terminate our Tennessee Multi-Sector Permit for the facility located at **River Mile 61 Nolichucky** located in Greene County, Greeneville, TN. Summers Taylor Inc. corporate office is located at 300 West Elk Avenue, Elizabethton, TN. (phone: 423-543-3181). The reason for termination is that Summers Taylor Inc. no longer has any types of equipment or operations at this property. This property has not seen any activity since 2014 thus the reason for termination.

"I certify under penalty of law that all stormwater discharges associated with industrial activity from the identified facility that are authorized by an NPDES general permit have been eliminated or that I am no longer the operator of the industrial activity. I understand that by submitting this notice of termination, that I am no longer authorized to discharge stormwater associated with industrial activity under this general permit, and that discharging pollutants in stormwater associated with industrial activity to water of the state is unlawful under the Clean Water Act where the discharge is not authorized by an NPDES permit. I also understand that the submittal of this notice of termination does not release an operator from liability for any violations of this permit or the Clean Water Act."

Under authority of the Tennessee Water Quality Control Act of 1977 (T.C.A. 69-3-101 et seq.) and the delegation of authority from the United States Environmental Protection Agency under the Federal Water Pollution Control Act, as amended by the Clean Water Act of 1977 (33 U.S.C. 1251, et seq.):
