Receipt is acknowledged, on February 21, 2024 for the above referenced Preliminary Engineering Report. The project is associated with PWSID No. TN0000531.

The chosen alternative generally consists of 9,100 linear feet of 6-inch PVC water line, valves, hydrants and all related appurtenances in the Petros area of Morgan County. **Included in this Preliminary Engineering Report is work not in the original application scope. This work includes an additional 4,500 linear feet of 6-inch water line, valves, hydrants, and all related appurtenances to replace Asbestos Cement water lines on Woods Cemetery Road, Curtain Road, and Adcock Hollow Road. Additional water line extensions to loop existing water lines was included in the quantities above. All work is being installed by Cumberland Utility District staff with portions of the work completed by a boring contractor. The Preliminary Engineering Report states the work is complete.**

The Engineering Services Unit has no objection to the chosen alternative.

The engineer should upload the PER and this memo to GMS as part of the ARP process. To expedite matters the engineer should reference the assigned ARP grant application ID with future submittals for this project. This project is subject to review by SWIG for compliance with project scope and grant requirements.
