On April 6,2023, David Phillips of the Division of Water Resources visited your system and performed a Sanitary Survey. The Survey consisted of a records review and onsite inspection of the distribution system to document the operational performance of the system. The Survey covered the time frame of October 26, 2021 to April 6, 2023. I would like to thank you, Mr. Jonathan Demps and staff for the courtesy and timely response to division requests. Quebeck-Walling Utility District earned 421 points out of a possible 421 points for a numerical score of **one hundred** (100%). This rating places Quebeck-Walling Utility District in the State's "**Approved**" category.

**General Observations, Comments, and Other Recommendations.**


- State approval to free chlorine residual analysis is granted to Mr. Jonathan Demps. This approval is valid until the next Sanitary Survey and is contingent upon proper operation, calibration, and maintenance of equipment.
- The bacteriological sampling rate for Quebeck-Walling Utility District **will increase to seven** (7) beginning **June 1, 2023** based on the population served.
