Good morning Mr. Clark and Mr. Miller,

Thank you for visiting with me (and Norma Branch) yesterday at the Crystal Steel facility. Just to quickly summarize, I informed you that coverage under the TN Multi-Sector Stormwater Permit (TMSP) is required for all facilities engaging in metal fabrication activities under Sector AA. You can find more information about the TMSP at <a href="http://www.tn.gov/environment/article/permit-water-npdes-industrial-stormwater-general-permit">http://www.tn.gov/environment/article/permit-water-npdes-industrial-stormwater-general-permit</a>. The reason the TMSP is required is because activities such as painting, cleanup of spills and drips, transportation of materials, surface treatment, galvanizing, storage of uncoated steel, etc., have the potential to cause pollution when the activities are conducted outside and exposed to stormwater. The stormwater runoff from these areas may discharge pollutants directly into nearby waterbodies or indirectly via storm drain systems, thereby degrading water quality.

In order to obtain coverage under the TMSP, a completed Notice of Intent should be submitted to the Division. I provided a blank Notice of Intent form yesterday, and an electronic version is aviable on the website provided above. The Notice of Intent form requires information regarding the operator/owner, facility, site location and size, industrial activity, material handling, discharging points and water receiving the discharges, existing permits, and other information. Please refer to Section 2 of the TMSP for more information regarding notification requirements. A Stormwater Pollution Prevention Plan (SWPPP) must be developed prior to submittal of a Notice of Intent. The Division recommends submitting a copy of the SWPPP with the Notice of Intent. Please refer to Section 4 of the TMSP and Section 3 of Sector P for more information regarding SWPPP requirements. If a SWPPP is unable to be generated by the deadline provided below, I recommend

submitting the Notice of Intent along with a letter or email stating that the SWPPP is under development and will be available and submitted by XX date.

Yesterday, I provided Mr. Miller with several documents related to the permit. Electronic versions of all of those doucments are provided on the website listed above. Mr. Miller asked also about fees yesterday. The TMSP does not have an application fee; however, there is an annual maintenance fee for the permit, and the fee is based on acreage of industrial activity exposed to stormwater (i.e., anything under roof can be subtracted from the acreage). The fee for 5-10 acres is 420/year, and the fee for 10-25 acres is 480/year. This information can also be found on our website.

Please have the Notice of Intent submitted to the Division by **April 12, 2019**. You may submit the Notice of Intent to me, electronically or via mail, and I will ensure that our Central Office is Nashville receives it. If you have any questions or comments in the meantime, please let me know, and I will do my best to assist! I realize that this permitting process is very new to you so you may have some questions along the way.
