Dear General Manager Cathey:

The Division of Water Resources (Division) recently conducted a compliance review of Pace Analytical National Center for Testing and Evaluation laboratory in Mount Juliet, Tennessee (Pace MJ). In conclusion of this review, it was determined that the Pace MJ did not obtain certification approval from the Division for the following Inorganic Secondary parameters: Odor by SM 2150B, and Color by SM 2120B.

Although this laboratory was never approved to submit these results for compliance purposes, the Division is only requiring resubmittal of samples collected since January 1, 2020.

According to our records, Lewisburg Water System submitted samples to Pace MJ for Color and Odor analysis from locations TP001 collected on 2/10/2021. These samples are now invalidated.

A new sample must be collected within 30 days of receipt of this letter. A list of laboratories certified by the Division for each these parameters is attached.
