COMPLIANCE AGREEMENT

Dear Mr. Anderson:

On September 27, 2011, the Tennessee Department of Environment and Conservation, Division of Solid Waste Management, conducted a Compliance Review Meeting with you in regard to alleged violations of the Tennessee Solid Waste Disposal Act occurring at your property located at Lamons Quarry Road in Knox County, Tennessee.

During the course of the meeting, alleged violations and other information were discussed. This letter is written to document the agreements reached during the Compliance Review Meeting. As agreed, the following actions must be taken to bring your disposal site into compliance with the Tennessee Solid Waste Disposal Act.

- (1) Submit permit modifications for construction, if needed, for Division approval.
- (2) Leachate lines must be connected, cannot recirculate leachate into or thru waste.
- (3) Control run on storm water by **October 17, 2011**.
- (4) Submit repair summary for leachate system by **October 31, 2011**.
- (5) Pond sample results (if not impacted) or pumping report (if impacted) by **October 17, 2011**.
- (6) Keep record of when the waste is covered, i.e. date, time stamped photos can be used.  
this shall be done for 1-year starting on this date.
- (7) Rills, storm water ditches repaired on the closed portion of F-1 by **October 31, 2011**.

The reports shall be submitted to the Division by the dates listed above. After the respective dates, a follow-up investigation by this office will be conducted to determine the status of compliance with this agreement.


