The attached Notice of Determination (NOD) outlines the decision made by TDEC regarding the proposed Water Authority of Dickson County (WADC) Water Reclamation Facility. The Department proposes to deny this permit on the grounds that WADC has not demonstrated that greater than de minimis degradation of Lick Creek (Exceptional Tennessee Waters) is necessary to accommodate important economic or social development in the area of the discharge and has not demonstrated that less-degrading alternatives are not practicable.

Your feedback has been instrumental in our deliberations, and while the comment period has concluded, we remain committed to transparency and accountability in our decision-making process.
