Good afternoon!

The application for your Conditional Major operating permit no. 481932 has been assigned to me. I am currently reviewing the application and beginning the permitting process. The application has been deemed incomplete.

Additional information is needed to continue processing the application.

1. What is the manufacture date of the plant equipment?
2. Verify if there are any insignificant/exempt activities that emit CO.
3. Provide an agreement letter, template attached for your reference. The calculated source specific allowable CO emission limit is 65.00 ton per 12 consecutive months. To avoid annual recordkeeping of insignificant/exempt activities, you can add 5 tons per 12 consecutive months to include any insignificant/exempt activities at the site. The facility wide limit will be 70.00 ton per 12 consecutive months. Please be sure to include a stated yearly production limit as well as a facility wide limit for CO that includes an additional 5 tons per 12 consecutive months to account for any insignificant activity in the agreement letter.

On behalf of Franklin Asphalt, Inc. the following limitations are agreed upon for the above referenced facility.


Production Limit shall not exceed 325,000 tons on all intervals of 12 consecutive months.
