Concerning complaint 126016 as described in the email chain which follows: New barrel houses are being constructed but the facility has provision for the construction of additional barrel houses in their current operating permit. The facility currently has a pending T5 renewal as well as a pending minor modification to the current permit to add an additional 23 whisky maturation warehouses. The mention of filtration and thus design of the barrel houses associated with this complaint has been referred to our permitting section who are working with the facility to obtain additional information needed. Tip or Complaint: The Jack Daniel's distillery has built 7 65,000 sq foot aging warehouses. These each contain over 66,000 barrels of whiskey. They have built these building with HVAC and ethanol monitoring systems. The temperature and the humidity are maintained at pre described settings and there are only 4 exhaust points from the building. Air handling moves the air through ductwork and exhausts over 500 TONS of ethanol from each building annually. Jack Daniel's has not notified the EPA nor TDEC of this change in barrel house construction and so they are illegally emitting ethanol in excess of the 100-ton annual limit per stationary facility. I have attached the building plans for these structures, and you can plainly see the building is completely sealed and uses a control system to monitor the temperature, humidity, and Lower Explosive Level (LEL) for each structure. These ARE NOT FUGITIVE and should be using emissions controls such RTO to eliminate the containment
