PETITION FOR REVIEW AND HEARING

Pursuant to the Tennessee Uniform Administrative Procedures Act, T.C.A. §§ 4-5-301, et seq., and the Tennessee Air Quality Act, T.C.A. §§ 68-201-101, et seq. (collectively the "Act"), including § 68-201-116, Petitioner, Providence Builders, LLC, hereby objects to the Technical Secretary's Order and Assessment of Civil Penalty, Case No. APC20-0105, dated February 7, 2022 and received by Petitioner on February 12, 2022 (the "Order"); appeals the Order and the assessment contained therein; and requests a hearing on this matter before the Tennessee Air Pollution Control Board.

Petitioner seeks, among other things, review of the alleged facts and violations included in the Order. Petitioner further seeks review of the assessment of civil penalties set forth in the Order on the grounds that, in light of all relevant facts and circumstances, including in particular the factors that must be considered under the Act when exercising enforcement powers, (i) some or all of the matters cited in the Order as violations are not violations, (ii) the civil penalties assessed in the Order are unreasonable and excessive, and (iii) the factors that may be considered when assessing a civil penalty do not support the imposition of the civil penalties assessed by the Order.

The foregoing is not an exhaustive list of the grounds and reasons for Petitioner's objections. Petitioner reserves the right hereafter to raise additional grounds and reasons by amendment of this Petition or otherwise.
