Dear Mr. Barnett:

The Division of Solid Waste Management (DSWM) is in receipt of your updated permit July 9, 2021 and received on August 6, 2021, requesting approval of up the dated PBR permit to the above referenced facility permit. Specifically, the updated permit request is to allow the Lighting Resources, LLC (2212 Buffalo Rd. Ste. 210) to accept Universal Waste Aerosol Cans for recycling, with no processing/puncturing of the can at the facility, accumulated to ship to a permitted processor.

After review of the minor modification application documents, several minor deficiencies require further clarification or revision and are listed below.

1. Provide updated 3rd party Closure Cost worksheet for the requested changes in the permit, namely to cover 10 cubic yards of universal waste aerosol cans.
2. Clarify in the Narrative of Waste Acceptance, second paragraph, if only "Universal Waste Aerosol Cans" will be accepted.
3. Add Universal Waste Aerosol Cans to response to Condition XIV.

A complete copy of the permit should be resubmitted when responding to the NOD. If the minor permit modification is approved, the JCEFO will need to have one "complete" hard copy and one complete electronic PDF version of the permit.
