Permit-By-Rule for a Solid Waste Processing Facility

Dear Mr. Guinn:

This letter will serve as official notice that the Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has approved your permit-by-rule notification for the referenced facility located in Montgomery County at 1309 Tylertown Road, Clarksville, Tennessee (latitude 36.635417° N/longitude -87.32225° W), for separation of metals and other recyclables from the waste stream. This facility shall be deemed to have a Permit-by-Rule, provided the criteria of Rule 0400-11-01-.02(2)(a)1 of Tennessee's Solid Waste Processing and Disposal Regulations are met, including the permit conditions as submitted with your application. The registration number for this facility is SWP630001526. This number should be used on all reports and correspondence to TDEC or DSWM regarding this facility.

In accordance with Rule 0400-11-01-.02(2)(a)1(xxiii), this solid waste processing facility is not subject to requirements for financial assurance based on the maximum storage capacity. As stated in the Permit-by-Rule criteria provided in the notification, the facility will have no storage of processed waste and all wastes received will be processed that day. Waste storage on the ground or in roll-off containers will result in a recalculation of the requirement for financial assurance or possible termination of the permit. No storage of municipal solid waste will be permitted.

With the issuance of this permit, there is an annual maintenance fee required [pursuant to Tennessee Rule 0400-11-01-.07(3)] for this processing facility. This year's fee has been prorated for the period covering August 8, 2016 through June 30, 2017 (326 days). Your prorated fee in the amount of \$2,679.45 is based on the annual fee of \$3,000 for a processing facility. You will receive an annual maintenance fee invoice from TDEC's Division of Fiscal Services that will indicate that MPG Rentals NCPTS owes \$2,679.45.
