## **RE:** Revised Permit-By-Rule Approval – Removal of Materials Exempt from Rule 0400-11-01 Lighting Resources, LLC, Buffalo Road Processing Facility – SWP900001576

Dear Mr. Barnett:

As required by Rule 0400-11-01-.02(6)(b)1 of the Solid Waste Processing and Disposal Regulations, the Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has reviewed your revised notification to the Permit-By-Rule (PBR) for the Lighting Resources, LLC (SWP900001576) facility received March 24, 2023. The revised notification was submitted in response to a DSWM letter dated March 3, 2023 regarding Rule 0400-11-01-.02(1)(b)3(viii) which states that wastes regulated under Chapter 0400-12-01 (Hazardous Waste Management Rules) are not subject to the requirements to have a permit under Chapter 0400-11-01 (Solid Waste Management Rules). This revision results in the removal of several waste streams that are regulated under Rule 0400-12-01 (Hazardous Waste Processing PBR. Lighting Resources, LLC will continue to process Polychlorinated biphenyl (PCB) Ballasts that are not regulated under TSCA, Alkaline Batteries not regulated under Rule 0400-12-01, E-Wastes/Electronics not regulated under Rule 0400-12-01, and Automotive Parts, excluding airbags and seatbelt pre-tensioners.

Therefore, DSWM is notifying you of the results of this review in accordance with Rule 0400-11-01-.02(6)(b)2(ii). DSWM approves the revised notification documents.

Per Rule 0400-11-01.02(2)(a)1(xxiii) solid waste processing facilities must file a financial instrument with the State of Tennessee in an amount sufficient to insure the proper closure of the facility. There is currently \$172,084 on file. The new required financial assurance amount is \$23,082.
