

The General NPDES Permit for Discharges of Storm Water Discharges from Industrial Activities, Permit Number TNR050000, was issued on April 14, 2015 and became effective on April 15, 2015. To obtain coverage under the permit, you must submit a Notice of Intent, NOI.

Permit coverage under your tracking number (TNR056007) was administratively extended when the permit expired on May 15, 2014. Submission of this completed NOI is required to continue permit coverage under this new 5-year general permit issued April 14, 2015. If we do not receive your completed NOI by May 31, 2015, your permit coverage will be administratively inactivated, and discharges of storm water associated with industrial activity after that date will be a violation of state law.

You will find a partially completed NOI showing the facility information that the Division of Water Resources (division) has on record for your facility. Complete all sections of the NOI, make corrections to any errors that you find, and submit the completed and signed NOI to the division. Incomplete NOIs will not be accepted. Signed and completed forms should be sent to the appropriate division address listed on the NOI instructions:
