Dear Mr. Hart:

On behalf of the Commissioner Salyers and the Tennessee Department of Environment and Conservation, the Division of Water Resources (the division) acknowledges receipt of your letter dated January 31, 2022.

The Water Authority of Dickson County is planning a new publicly owned treatment works (POTW) to provide sewer service to the western portion of its sewer service area. At this time, the location of the treatment facility has not been identified. Therefore, the sign was posted near the proposed new discharge location on January 10, 2022, and amended to add the date on the sign on January 24, 2022. The sign will remain posted until February 25, 2022. The sign is legible from a public road, and has fulfilled its intended role of ensuring that local residents are aware of the proposed new discharge.

The division has not yet prepared a draft permit and rationale for this proposed discharge. When the division has done so, it will provide public notice of the draft permit and the public hearing. The notice will be issued at least 30 days prior to the public hearing and will provide at least 30 days to submit comments concerning water quality aspects of the draft permit. Also associated with that public notice, the division will public notice a revised draft permit to solicit comments.
