This email is to acknowledge the receipt of your email below. The Water Authority of Dickson County is planning a new publicly owned treatment works to provide sewer service to the western portion of its sewer service area. Please see attached the engineering report submitted by the Authority's design consultant that describes the need and scope of the project. We have not yet public noticed a draft permit for public review and comment. Pursuant to Rule 0400-40-05-.06 (8), public notice of a public hearing shall be given at least 30 days before the hearing.
