In accordance with 40 CFR Part 63 Subpart YYYYYY, National Emission Standards for Hazardous Air Pollutants for Area Sources: Electric Arc Furnace Steelmaking Facilities, Gerdau, Jackson Tennessee Steel Mill is submitting the semiannual compliance report covering January 1, 2014 through June 30, 2014, required under Section 63.10685(c)(3).

Gerdau, Jackson Tennessee Steel Mill has not deviated from the requirements for the control of contaminants from scrap, as outlined in Section 63.10685(a)(1) and (a)(2).

Gerdau, Jackson Tennessee Steel Mill only procures scrap from suppliers that participate in the National Vehicle Mercury Switch Recovery Program. As such, the mercury compliance option under Section 63.10685(b)(2) applies to each scrap provider, contract, and shipment.
