I am sorry the draft permit caused some confusion upon your review and I hope this can help clarify any issues. Source 03 cannot be placed on the Operating Permit as it is not yet installed and does not have a startup certification. Adding it to the Operating Permit will need to be done with an amendment at a later date once the source is in operation and we have received startup certifications. In regards to the Insignificant Sources not being added to the permit not all operating permits just the Conditional Majors and the Title 5 permits have those listed. If the facility asks for it and they're a True Minor we will add it. With your comments in this email I will add the insignificant sources to the permit however, they will not have any source specific conditions attached to them and all applicable air pollution regulations must still be met by your facility.
