Mr. Miller,

I believe Brian Rivera is with the Knox County Air Quality Management program. That is a program within the Knox County government and they are the program that handles all Knox County air pollution permitting, known as a local air program (Davidson, Hamilton, and Shelby being the others in TN). As Powell is in Anderson County I believe, it should be handled through the [Knoxville Environmental Field Office](#). This is a regional office of the State of TN and though it is located in Knox County, the Air Pollution Control (APC) division there handles air pollution issues in the region with the exception of Knox County.

Unfortunately, the SBEAP is a completely non-regulatory program and so cannot make decisions on scheduling of performance tests as that would fall entirely within the purview of APC. As this email was also sent to the general APC email, it should be forwarded to the Knoxville Environmental Field Office. However, you may also wish to contact Jarrett Rudd at (865) 594-5568 or at [Jarrett.L.Rudd@tn.gov](mailto:Jarrett.L.Rudd@tn.gov) or [APC.KnoxEFO@tn.gov](mailto:APC.KnoxEFO@tn.gov). Mr. Miller,

Thank you for contacting the Small Business Environmental Assistance Program concerning performance test notification. In regards to tests for Stage I systems for air pollution requirements, the general requirements found in 40 CFR 63.9 and 63.7 referenced in the 40 CFR 63 Subpart CCCCCC rules require a 60 day notification. As the 6C rule was incorporated by reference into the State of TN rules, this time frame for performance test notification would be the applicable requirement. Beyond this correction, you do have the information correct. I think your template would also meet the requirements for a performance test notification, though as APC was also contacted, they would be able to confirm for sure. [Air.Pollution.Control@tn.gov](mailto:Air.Pollution.Control@tn.gov) would be the APC email to send performance test notifications to. The SBEAP website has a [timeline of common notifications and permit lead times](#) for gasoline stations on our website that we try to keep up to date.

I have recently come to understand that Stage 1 tests at gas stations in the state of TN require a 15 Day Notification (with the exception of Knox, Hamilton, Davidson, and Shelby counties, which may

require additional time). I have also learned that notifications can be sent to this email address and should include date and time of test, site information, testing company information, test procedures, and test equipment to be used.

Is this understanding correct?

Can you also take a moment to review the following notification example and let me know if any additional information is needed?
