Dear Mr. Allen or responsible official:

The Division of Air Pollution Control is completing file reviews to identify permits approaching their expiration date. It has come to our attention that permit number **065162P** is due to expire **February 15, 2022**.

Pursuant to Tennessee Comprehensive Rules and Regulations 1200-03-09.02(3)(a), an application for an operating permit shall be filed with the Technical Secretary not less than sixty (60) days prior to the expiration of an existing operating permit. Therefore, the deadline to submit a Notice of Intent or renewal application is **December 17, 2021**.

The Division recently implemented Permit-by-Rule for Paint Stripping and Miscellaneous Surface Coating Operations at Area Sources, 40 CFR Part 63 Subpart HHHHHH (6H). This option allows qualifying facilities to submit a Notice of Intent for authorization under Permit-by-Rule, and receive a Notice of Authorization to construct, modify, or operate a minor air contaminant source according to the rules relating to its industrial category. **The Notice of Authorization will take the place of a permit that was previously written specifically for your facility.**

Form APC 202 or APC 100 may be submitted via email to Air.Pollution.Control@tn.gov. The submittals must be signed, dated, and in PDF format. Please include your Facility ID as well. If preferred, paper documents can be mailed to the Technical Secretary at the address included on the forms.

Note: In addition to the Permit-by-Rule or permitting requirements of 6H, all Paint Stripping and Miscellaneous Surface Coating Operations at Area Sources must also meet the requirements of Tennessee Comprehensive Rules and Regulations 1200-03-09.
