Good morning,

This email is to request the review of permit 32-0215-081059 from the Knoxville Environmental Field Office. Upon review of the last permit, it was found to have some errors which needed to be addressed using the new permit format. The most notable differences are:

The new permit contains emission limitations on CO, NO<sub>x</sub>, and VOCs (Volatile Organic Compounds).

The new permit requires an updated agreement letter with a compliance method for the stated emission limitations.

The new permit is formatted to our most current version and includes general requirements for all air contaminant sources.

Attached is the first draft of permit 081059.

In order to continue processing this permit, a new agreement letter is required for the limits on PM (TSP) and SO<sub>2</sub> emissions along with your approval of the first draft. An agreement letter for this source was submitted to the division on May 23, 2000, requesting limits on SO<sub>2</sub> and PM (TSP) as 15.97 lbs/hr and 0.45 lb/hr respectively. The existing agreement letter does not include a compliance method and therefore a new letter is required. If a new limitation is requested, the permit will need to be modified accordingly.

Once we receive the updated agreement letter and approval from both the facility and the EFO, issuance of permit 32-0215-081059 can proceed. Submit any comments on this permit by September 28, 2023.
