With this letter, Heraeus Precious Metals North America, LLC (Heraeus) submits an administrative permit amendment request to incorporate the minimum pressure drop value for the baghouse at Source 65-0049-13. A wet scrubber was added to the source for product collection under a minor modification request dated November 24, 2020. With the installation of the scrubber, the pressure drop would be affected, so a new pressure drop value is required. Source 13 operates when material is available, so operating days have been spread across the year as indicated in the attached log. The new setup was first operated on January 21, 2021, and pressure drop values have been compiled for thirty (30) days of operation. Heraeus proposes a minimum pressure drop for the new baghouse at 65-0049-13 of 0.1 inch of water column.
