The Division received the operating permit application on March 11, 2021, for the weighing tote dump station (source 08) located at the Colgate Palmolive facility in Morristown, TN. Condition G15 of permit 978408 requires that a start-up certification for the new source be submitted to the Division no later than 30 days after the air contaminant source is started up. Condition G11 of permit 978408 requires that the operating permit application be submitted to the Division within 30 days of initial start-up of the new source. I do not see where we have received the start-up certification for this source.

Was the start-up certification for source 08 submitted to the Division?
