## Good afternoon Riley,

Thanks for the quick reply – the APC 102s you attached were in the original application, those are the ones for the three boilers [Source 04]. In the application though, there is also:

Rubber Extrusion Lines #3 & 4 (using cyclohexanone and S-5995) – [Source 06]

- o Is rubber actually being extruded, or is this a gluing line that's mis-labeled? If there's actual rubber extrusion going on, there are some (small) VOC emissions that I need to document. In that case I would need to know the production rate.
- Liquid Cure Process (using oxidizers) [Source 12]
  - This was previously marked as an insignificant source, which it probably is, but I need to show calculations, so production rate is needed.
- Vulcanizers #2-7 and 2 Vertical Vessels (steam curing) [Source 16]
  - Same as the liquid cure production rate needed.

Usually those production rates would be listed on the APC 102 forms in Section 9, but I only see the APC 101 forms for those processes. If you don't have the originals, submitting a new version is fine.

To add on to what I mentioned before, FRS is currently permitted as a "Conditional Major" facility, which requires additional fees and annual reporting. Based on the changes over the last few years, it can probably be reclassified as a "True Minor" facility to remove those requirements, but in order to do so I have to demonstrate that the facility-wide emissions are below the EPA threshold (including the insignificant sources).
