NOTICE OF INTENT TO ISSUE PERMIT
FOR A SOLID WASTE DISPOSAL FACILITY

The Tennessee Department of Environment and Conservation (TDEC), Division of Solid Waste Management (DSWM), has tentatively decided to issue a solid waste disposal facility major modification to the Town of Greeneville for construction, operation, closure, and post-closure care of a vertical expansion to the existing Class III Landfill for the disposal of construction/demolition wastes, shredded automotive tires, silica sand or partially fused silica sand, and certain wastes having similar characteristics and approved in writing by the Department.

The facility, identified as DML300000062, is located in Greene County, at 1555 Old Stage Road, Greeneville, Tennessee (latitude 36°11'42" N/ longitude 82°45'32" W). No hazardous wastes, as regulated by the Tennessee Hazardous Waste Management Act (Tennessee Code Annotated, Section 68-212-101, et. seq.) and the Rules adopted pursuant to the Act, shall be accepted for disposal at this facility. Under the SWM Permits tab, type in DML300000062 in the search function to link to the Greeneville/Greene County Class III Landfill information.

Following an in-depth review of the application, DSWM has made a preliminary determination that this proposal meets the applicable requirements of Tennessee Rule Chapter 0400-11-01, Solid Waste Processing and Disposal. It is the present intent of DSWM, pending consideration of any contrary technical information received during the public comment period ending on August 4, 2014, that this permit be issued. During the public comment period provided, any interested person may submit written comments on the draft permit and may request a public hearing. A request for a public hearing shall be in writing and shall state the nature of the issues proposed to be raised in the hearing. After considering all public comments, the DSWM Director will issue a final permit decision and a Response to Comments, which can be viewed at the Greeneville-Greene County Public Library or at the TDEC Field Office in Johnson City; or at the TDEC William R. Snodgrass Tennessee Tower.
